Important Points for Admission

(as per Govt. Notification No. AHE-11/862/2023-Hgher Education dated 04/07/2026 .)

1. Students whose parental annual income is less than Rs. 4.00 lakh from all sources are eligible for free Admission.
2. Students who have arrears/backlogs in the previous academic year shall not be eligible to avail the Fee Waiver Scheme Further, students who have not enrolled for the final examinations of the previous academic year shall also not be eligible to avail of the Fee Waiver Scheme.
