



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered into by and between Dhamdhama Anchalik College, Dhamdhama and The Green Globe- a Nature Based Non-Governmental Organisation, Nalbari.

Dhamdhama Anchalik College, Dhamdhama is situated in Nalbari District of Assam. This is a provincialised higher educational institution of Assam Government. The college is registered under the Sections 2f and 12(B) of the UGC Act, 1956. The objectives of the college are to provide quality education, guide the students to develop total responsibility and to motivate them to involve in social and community welfare.

The Green Globe is a Non-profit Non-Government Organisation, which was established under Society Registration Act bearing no RS/NAL/246/J/164 of 2013-2014 and it is registered with the NITI Ayog, 12A, 80G. The main aim and objective of the organisation is to conserve the ecosystem, aware people about climate change & global warming, agro-forestry and ways to earn a livelihood by means of sustainable source of earnings. To be passionately dedicated towards the mission, provide fair services to its target segments & inculcate passion towards saving nature through its activities. The organisation has a team of project management for smooth implementation of the project headed by President and Secretary of executive committee.

PURPOSE:

This document is based on the principle of mutual benefit and Dhamdhama Anchalik College and The Green Globe hereby agree to undertake activities focussing on enrichment of knowledge and co-operate in establishing closer links involving: -


- Organised or Participate Joint Conference, Workshop, Projects on nature conservation
- Waste management programme
- Outdoor nature conservation activities
- Plantation, Transplantation, Maintenance of saplings, plants
- Working for Less Carbon lifestyle

COMMITMENTS:

- i) This agreement shall become effective from the date of its signing and continue thereafter for five years subject to revision of modification by mutual agreement.
- ii) Termination by one institution, with prior intimation to the other institution before at least three months, will automatically invalidate the MoU.
- iii) In case of any controversy regarding scope and any provision of this MoU, mutually agreed decision of Principal, Dhamdhama Anchalik College and President/Secretary of The Green Globe will be final.
- iv) This document is a statement of understanding and is not intended to create bindings or legal obligations on either party.
- v) Except in the noting provisions of this MoU, no use of the name, symbol, sign of one institution shall be made by the other.
- vi) Financial involvement in connection with any programme undertaken as per the MoU will be arranged by Dhamdhama Anchalik College.
